## **City of Racine Technical Assistance Plan**

As a part of the Upper Midwest SolSmart Cohort, **Racine** is one of over 40 communities working to remove barriers to solar development through SolSmart designation. Townships, cities, and counties across Minnesota, Iowa, and Wisconsin are a part of this cohort.



**Timeline:** If Racine is aiming for silver or gold designation, you must submit for bronze by **June 28**. After bronze designation, MREA will continue working with you to reach silver or gold. If bronze is your final goal, you must submit for it by **October 11**.

The sooner you submit for bronze, the more likely you are to achieve it. If there are any actions that need additional documentation, we will have the time to gather that and resubmit.

Racine needs to meet all 3 prerequisites (PR-1, P-1, and PZD01a, as well as earn 60 total points to meet the requirements for bronze designation! 20 points have already been earned, you're half way there!
