Karen Scherer (1015 Romayne Avenue) – No vote at this time. Wanted to know why the homeowners are assessed the cost if the City owns the alley and had other cost questions. She doesn't use the alley because she doesn't have a garage. Believes that most of the damage in the alley is because of Roosevelt School traffic. Wanted to know if speed bumps would be installed if the alley is paved.

John Rooney – Explained that alleys are public right-of-way. The cost is \$52 per front foot. City will pay for any storm sewer costs. If job costs are to Finance Department before end of tax season it will be on your property tax bill. If it does not get to Finance by then, it will be invoiced the following year. No tax advice can be given. We do not have a policy for installing speed bumps in the public right-of-way.
