October 15, 2019	All Staff Health Department	Updates	Conducted an all staff meeting to discuss updates on medical insurance, budget and schedule. A presentation was provided by Child Protective Services on Mandatory Reporting. All staff received their influenza vaccination.
October 22, 2019	Wisconsin Department of Health Services Hepatitis C	Rapid Testing Training	To enhance comprehensive services with the Needle Exchange Program, the Public Health Department has been chosen to pilot rapid Hepatitis C testing.
October 28 – 29, 2019	Narcan Presentation at Twin Disc	Employer Narcan Training	Training conducted for 57 employees designated as First Responders by Twin Disc to respond and administer Narcan in the workplace.
October 29, 2019	Racine Unified School District INSPIRE Program	Cribs for Kids	INSPIRE is a program for female high school students who are pregnant or who are parents. Students were educated on safe sleep and provided a pack-n-play to ensure a safe sleep environment for their infant.
October 2019	Opioid Overdose Grant	Opioid Overdose Home Visits	In collaboration with the Racine Fire Department, 10 home visits were conducted to provide resources, education, and Naloxone to patients, families, and friends of those affected by addiction.
