BACKGROUND & ANALYSIS:

- 22 Kelsey Thomas, of 2553 Hansen Avenue, Racine, WI 53405, filed a claim for reimbursement requesting
- 23 \$3,300.00 in damages to his vehicle, which was parked on a City street and allegedly struck by a privately-
- 24 owned vehicle that was fleeing from police on or about November 8, 2019.
- 25 On the afternoon in question, Mr. Thomas's vehicle was parked on a City street, specifically, the 2300
- block of Hansen Avenue, and was unoccupied. The vehicle that allegedly collided with Mr. Thomas's 26
- vehicle was owned and operated by a private party. The operator of the vehicle that allegedly collided with 27
- 28 Mr. Thomas's vehicle was fleeing from police at the time of this incident, and was not acting as an agent
- or employee of the City at that time. 29

30 31 32	Because these damages were caused by an individual who was operating a privately-owned vehicle and was not acting as an agent or employee of the City, the City is not liable for these alleged damages. For this reason, it is the recommendation of the City Attorney's Office that this claim be disallowed.
