Investigations Conducted:

• Complainant is a white female in a same sex marriage. She has three children and is pregnant. CP moved in with her partner in October 2019, the property owner would not acknowledge the same sex partner and kept saying "friend" while using air quotes. The complainant had her children visit and the property owner became angry with her children, yelling at them, threatening them, etc. The unit has major maintenance issues and the property owner is reluctant to complete repairs. The complainant feels the property owner is being rude and disrespectful because she is in a same sex couple. She wants to file a Fair Housing case, but would like to move out of the unit before filing for fear of retaliation*. The complainant is working with other service providers in Racine and staff will help coordinate all of those efforts.

*Retaliation under the Fair Housing Act is forbidden (Federal, State, and Local).

FILED (Alleged) COMPLAINT (S) w/HUD or ERD:

COMPLAINT UPDATE:

• The complainant is a single, black, female who had her father move in with her and required a reserved parking space with truncated lines. The property manager threatened to have her towed because she was parking in the designated spots at the front of the building. Staff helped her put a request to have a reserved spot with truncated lines and the management said "parking is at a premium, we can't reserve them, they are first come first serve. Maybe you need to be more careful about when you leave and return" Staff referred the case to Metropolitan Milwaukee Fair Housing Council for legal assistance, the case was settled in January 2020.
