Attached for your consideration is a communication from Racine County providing the bid results associated with the purchase of road salt for this winter season. The County awarded this bid to Compass Minerals America, Inc., at their bid price of \$69.93 per ton.

This is a reduction of \$27.60 per ton over the rate paid for road salt last Winter Season.
