DIVISION I

GENERAL CONDITIONS

- 1.2 <u>SCOPE</u>: The Vendor shall submit a lump sum price bid for supplying and installing exterior sound system in accordance with these Detailed Specifications and Schedule "A."
 - 1.2.1 Bidder's Proposal must be complete and must include the following:
 - 1.2.1.1 All costs for providing equipment, shipping, unloading, field fabrication and installation of external sound system.
 - 1.2.1.2 Vendor must submit a computer generated "Sound Model" of the project area with speaker locations and sound levels.
 - 1.2.1.3 All documentation to support specification requirements.
 - 1.2.1.4 Drawings and layout of all proposed equipment.
 - 1.2.1.5 Start-up, balancing and tuning of all system components.
 - 1.2.2 Vendor shall provide all the following equipment with the Lump Sum Bid.
 - 1.2.2.1 External speakers sufficient to comply with "Best Industry Standards."
 - 1.2.2.2 All equipment and accessories required to operate external speaker system.
 - 1.2.2.3 Two (2) fixed location microphones in football pressbox.
 - 1.2.2.4 Two (2) wireless remote location microphones capable of transmitting the full range of the project area as listed in Schedule "A."

- 6.2 The Contractor is responsible for knowing and following the criteria outlined in the plans and specifications.
- 6.3 Contractor shall secure all permits and pay all fees required for the work under this contract.
- 6.4 Contractor will be held responsible for any damage to surfaces and will be required to clean or repair any damaged surfaces to Parks Department satisfaction.
- 6.5 Any surfaces damaged beyond repair shall be replaced at Contractor's expense.

DIVISION 2

STANDARDS

1 Work Included

- 1.2 Remove existing speaker system turn over to Owner.
 - 1.2.1 Fill all previous speaker mounting holes with matching caulk.
- 1.3 Supply all equipment, microphones speakers, other equipment and installation materials per plans & specifications.
 - 1.3.1 Run wires or proper conductors to each speaker location.
 - 1.3.2 See Schedule "A" for locations of existing wireways.
 - 1.3.3 Lengths of wireways are for bidding purposes only contractor is responsible to field measure wireways before installation of conductors.
- 1.4 Provide all lifts, lifting devices and ladders to complete the scope of this project.
- 1.5 Protect all bleachers, light poles, football pressbox and other related surfaces from damage during construction.
- 1.6 Fabricate mounting devices and install equipment to Manufacturer's specifications.
- 1.7 Connect to Owner provided power source in Football Pressbox 120 volt, 20-amp.
- 1.8 Properly balance/tune all speakers, microphones & listening devices to site and equipment conditions.
- 1.9 Test, operate and train designated PRCS personnel for operation of equipment.
- 1.10 Provide all operation, maintenance and inspection materials.
- 1.11 Dispose of all spoils and clean-up project area.
- 1.12 Perform all manufacturer required maintenance and inspections for one (1) year after completed installation.

2 Work Not Included

- 2.2 120 Volt, single phase, 3 wire, 20-amp outlet.
- 2.3 Football light poles are outfitted with OSHA approved climbing rigs. Vendor shall provide climbing harness.

4 Submittals

- 4.2 Submittals for all equipment proposed must be submitted with the Bidder's Proposal.
 - 4.2.1 All equipment included with Bidder's Proposal must be supplied & warranted by the same manufacturer or vendor.
- 4.3 Contractor shall provide estimate of number of days required to install specified equipment.

5 Demo

6 Quality Assurance

6.2 All exterior sound system components, equipment and installation shall be to "Best Industry Standards."

- Once started, the exterior sound system replacement project must run continuous without delays.
- 6.4 The Contractor shall employ adequate numbers of manufacturer trained, experienced, skilled workers for the project, who are familiar with all the methods, materials, requirements and standards required for proper installation and performance of the work specified in accordance with these specifications and best industry standards.

7 Shipping, Receiving & Handling of Materials

- 7.2 Vendor shall include the cost of shipping of all materials.
- 7.3 Contractor is responsible for unloading and staging of all materials.
 - 7.3.1 Owner <u>will not</u> provide any labor, rigging or equipment for unloading or transporting materials.
- 7.4 Delivery of materials must be during normal PRCS operational open hours.
 - 7.4.1 Contractor shall coordinate will the Owner Representative for delivery schedules.
- 7.5 Staging, storage & delivery areas will be designated by Owner Representative.

8 Insurance

- 8.2 The contractor shall provide the City with Certificates of Insurance. Such certificates shall be presented at the time the contract is signed. The certificates shall provide that all notices by the insurer to the insured shall simultaneously be sent to the City; that at least thirty (30) days prior to any cancellation of such coverage or any part thereof, written notice be given to the City, and that unless such notice is given the purported cancellation will be ineffective. The certificate shall show the following coverage
 - 8.2.1 Worker's Compensation in statutory limits covering all employees who perform any of the obligations assumed by the Contractor under this contract
 - 8.2.2 Comprehensive General Liability Insurance covering all operations under the contract; limits being a minimum of \$1,000,000.00 per occurrence single limit during the policy period including product liability and/or completed operations when applicable.
 - 8.2.3 Automobile Liability Insurance on all owned, non-owned or hired automobiles with a minimum of \$1,000,000.00 combined per occurrence coverage

DIVISION 3

PRODUCTS

1 General - Location

- 1.2 The following is general specifications that shall be considered generic, minimal criteria for external sound system.
- 1.3 Equipment Installation:
 - 1.3.1 See project scope and drawings included in Schedule "A."
- 1.4 Design Criteria
 - 1.4.1 Must comply with current IBC & ADA.
 - 1.4.2 Must comply with "Best Industry Standards" for stadium sound systems.

1.5 Minimum External Speaker/PA Requirements

- 1.5.1 Submittals shall be provided with the Bidders Proposals for speakers, microphones, amplifiers, mixers & transmitters.
- 1.5.2 Provide sound model that projects the sound clarity and distribution of sound level throughout the project area. Sound model shall provide best areas to transmit with remote microphones.
- 1.5.3 All exterior mounted equipment must be rated and approved for outdoor use.
 - 1.5.3.1 All metallic mounts, brackets, nuts, bolts, washers, clamps and straps must be coated with rust preventative materials before installation.
- 1.5.4 Provide & install all equipment required to comply with provided sound model.
- 1.5.5 Provide all accessories listed in project scope.

1.6 <u>Microphones</u>

- 1.6.1 Submittals shall be provided with the Bidder's Proposals for microphones.
- 1.6.2 Fixed Units
 - 1.6.2.1 Shall have "On/Off" switch for each fixed unit.
 - 1.6.2.2 Shall have "Sneeze" button.
 - 1.6.2.3 Shall the ability to operate "Hands Free."
 - 1.6.2.4 Shall have the ability to replace "Foams."
 - 1.6.2.5 Mounts/Supports shall be flex material that can be easily adjusted to speaker heights.
 - 1.6.2.6 10" minimum counter to receiver height with ability to raise and lower an additional 8."

1.6.3 Portable Units

- 1.6.3.1 Shall have the ability to transmit clearly within the entire project area.
- 1.6.3.2 Shall have "On/Off" switch for each fixed unit.
- 1.6.3.3 Shall the ability to operate "Hands Free."
- 1.6.3.4 Shall have the ability to replace "Foams."
- 1.6.3.5 Shall have the ability to have "In-Use" operation for 3 hours minimum from a single battery change or battery charge,
- 1.6.3.6 Batteries type shall be commonly available or shall be rechargeable via USB port.
- 1.7 ADA compliant Radio Frequency (RF)
 - 1.7.1 System shall be capable of transmissions the full range of the project area as listed in Schedule "A."
 - 1.7.2 Any required signal boost devices shall be provided and installed by Contractor.
 - 1.7.2.1 Signal boost devices that require a 120-volt power source must be installed by the contractor. Cost shall be included in the Lump Sum price on the Bidder's Proposal.
 - 1.7.3 Radio Frequency shall transmit the signal over radio frequencies over the FCC-regulated 72MHz and 216MHz bands.
 - 1.7.4 Provide a minimum of ten (10) signs specifying frequencies for assisted listening.
 - 1.7.4.1 Signage "Shall Not" include any Manufacture's advertising without Owner's approval in writing.

1.8 Installation

- 1.8.1 Location for base system
 - 1.8.1.1 Football Pressbox
- 1.8.2 No equipment, lifts, trailers or any other vehicles will be allowed on the football field for any reason.
- 1.8.3 All speaker system components installed exterior or areas subject to exterior weather conditions shall be rated and warranted for exterior installation.
- 1.8.4 Existing wireways & approximate lengths.
 - 1.8.4.1 Wire lengths are for bidding purposes; contractor shall field verify all lengths before installation of system components.
 - 1.8.4.2 West Bleacher Football Lights 200'± each pole.
 - 1.8.4.2.1 Each pole has spare 1 ¼" wireway to each pole.
 - 1.8.4.3 East Bleacher Football Lights 500'± each pole.
 - 1.8.4.3.1 Existing wireways terminate under bleachers, approximately 150' of wireway would be require to be run above ground along the east bleacher framing to each light pole. Cost to run surface mound wireway or conductor shall be included in the Lump Sum on the Bidder's Proposal.
 - 1.8.4.4 Existing Scoreboard 350'±
 - 1.8.4.4.1 Existing 1" wireway may be used for new speaker components.
 - 1.8.4.4.2 Adding junction boxes or other openings shall be included in the Lump Sum on the Bidder's Proposal.
- 1.8.5 Existing Football Light Poles.
 - 1.8.5.1 1" mounting hub is located 35' above light base.
 - 1.8.5.2 <u>All mounting to light poles shall be with clamps or straps only! No</u> drilling, cutting or welding of light poles will be permitted.
- 1.8.6 Football Stadium Capacity
 - 1.8.6.1 East Football Bleachers 1519 Persons
 - 1.8.6.2 West Football Bleachers 2108 Persons

1.9 Fasteners

- 1.9.1 All fasteners, clamps, nuts bolts and washers, for exterior mounted must be provided by the equipment manufacturer.
- 1.9.2 Wall and floor mount fasteners must be approved by Owner Representative.
- 1.9.3 All fasteners must be metallic and be treated with anti-corrosion material before installation.

DIVISION 4

FINAL INSPECTION AND CLEANUP

1 General

Any existing equipment or structure, damaged during the course of execution of any phase of this contract, shall be repaired by the Contractor at the Contractor's expense. This includes any replacements needed, as determined by the Parks Department to restore damaged equipment, floors, floor surfaces, walls, doors or other structure(s).

- 1.3 No equipment, lifts, trailers or any other vehicles will be allowed on the football or baseball field for any reason
- 1.4 All refuse associated with any phase of this contract shall be immediately cleaned up and removed by the Contractor.
- 1.5 Contract shall not use Owner's waste facilities.

TIME LIMIT

1 General

1.2 Work on this project shall be complete by December 11, 2020

<u>DIVISION 6</u> GUARANTEE

1 General

- 1.2 Contractor shall agree and guarantee that the materials, equipment and workmanship supplied be the contractor, shall be free from all defects and strictly in accordance with the specifications at the time of its completion and acceptance by the City of Racine and for a period of one (1) year, thereafter; and in case of any cracks, leaks or settlement or any other defects as to materials, equipment or workmanship existing or appearing in any part of the work constructed by contractor within one (1) year thereafter, the Contractor agrees to forthwith repair the same upon notification by the City using the same materials required by this specification and in case the Contractor shall fail to make such repairs; the Contractor further agrees and guarantees to pay for all labor and material used in or about the construction of said work in this contract which may become a lien or a claim against the City. Such agreement and guarantee shall be made a part of the contract and the fulfillment thereof shall be secured by the bond of the Contractor.
- 1.3 Contractor or Manufacturer's representative shall provide training to Owner designee/s on proper operation and maintenance of external sound system.

6. Indemnification and Insurance Requirements:

Indemnification

To the fullest extent allowable by law, Contractor hereby indemnifies and shall defend and hold harmless the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers and each of them from and against any and all suits, actions, legal or administrative proceedings, claims, demands, damages, liabilities, interest, attorneys' fees, costs, and expenses of whatsoever kind or nature whether arising before, during, or after completion of the work hereunder and in any manner directly or indirectly caused, occasioned, or contributed to in whole or in part or claimed to be caused, occasioned, or contributed to in whole or in part, by reason of any act, omission, fault, or negligence, whether active or passive, of Contractor or of anyone acting under its direction or control or on its behalf in connection with or incident to the performance of this Agreement regardless if liability without fault is sought to be imposed on the City of Racine, Contractor's aforesaid indemnity and hold harmless agreement shall not be applicable to any liability caused by the sole fault, sole negligence, or willful misconduct of the City of Racine, or its elected and appointed officials, officers, employees or authorized representatives or volunteers. This indemnity provision shall survive the termination or expiration of this Agreement.

In any and all claims against the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers by an employee of Contractor, any subcontractor, or anyone for whose acts any of them may be liable, the indemnification obligation under this paragraph shall not be limited in any way by any limitation on the amount or type of damages, compensation, or benefits payable by or for the Contractor or any subcontractor under Worker's Compensation Acts, Disability Benefit Acts, or other employee benefit acts.

No provision of this Indemnification clause shall give rise to any duties not otherwise provided for by this Agreement or by operation of law. No provision of this Indemnity clause shall be construed to negate, abridge, or otherwise reduce any other right or obligation of indemnity that would otherwise exist as to the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers under this or any other contract. This clause is to be read in conjunction with all other indemnity provisions contained in this Agreement. Any conflict or ambiguity arising between any indemnity provisions in this Agreement shall be construed in favor of indemnified parties except when such interpretation would violate the laws of the state in which the job site is located. Contractor shall reimburse the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers for any and all legal expenses and costs incurred by each of them in connection therewith or in enforcing the indemnity herein provided. Contractor's obligation to indemnify shall not be restricted to insurance proceeds, if any, received by the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers.

Insurance Requirements

The Contractor shall not commence work under a contract until he has obtained all insurance required under this paragraph and has filed certificates thereof with the Owner, nor shall the Contractor allow a Subcontractor to commence work until all similar insurance required has been so obtained and filed with the Contractor. Unless otherwise specified in this Agreement, the Contractor shall, at its sole expense, maintain in effect at all times during the performance of the Work, insurance coverage with limits not less than those set forth below with insurers and under forms of policies set forth below.

Worker's Compensation and Employers Liability Insurance - The Contractor shall cover or insure under the applicable labor laws relating to worker's compensation insurance, all of their employees in accordance with the law in the State of Wisconsin. The Contractor shall provide statutory coverage for work related injuries and employer's liability insurance with limits of \$1,000,000 each accident, \$1,000,000 disease policy limit, and \$1,000,000 disease each employee.

Commercial General Liability and Automobile Liability Insurance - The Contractor shall provide and maintain the following commercial general liability and automobile liability insurance:

Coverage – Coverage for commercial general liability and automobile liability insurance shall be at least as broad as the following:

- a) Insurance Services Office (ISO) Commercial General Liability Coverage (Occurrence Form CG0001)
- b) Insurance Services Office (ISO) Business Auto Coverage (Form CA0001), covering Symbol 1 (any vehicle)

Limits -The Contractor shall maintain limits no less than the following:

- a) General Liability One million dollars (\$1,000,000) per occurrence (\$2,000,000 general aggregate if applicable) for bodily injury, personal injury and property damage. If Commercial General Liability Insurance or other form with a general aggregate limit is used, either the general aggregate limit shall apply separately to the project/location (with the ISO CG 2503, or ISO CG 2504, or insurer's equivalent endorsement provided to the City of Racine) or the general aggregate including product-completed operations aggregate limit shall be twice the required occurrence limit.
- b) Automobile Liability- One million dollars (\$1,000,000) for bodily injury and property damage per occurrence limit covering all vehicles to be used in relationship to the Agreement.

c) Umbrella Liability- One Million dollars (\$1,000,000) for bodily injury, personal injury and property damage per occurrence in excess of coverage carried for Employers' Liability, Commercial General Liability and Automobile Liability as described above.

Required Provisions - The general liability and automobile liability policies are to contain, or be endorsed to contain, the following provisions:

- a) The City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers are to be given additional insured status as respects liability arising out of activities performed by or on behalf of the Contractor; on products and completed operations of the Contractor; for premises occupied or used by the Contractor; and on any vehicles owned, leased, hired or borrowed by the Contractor.
- b) The coverage shall contain no special limitations on the scope of protection afforded to the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers.
- c) For any claims related to this project, the Contractor's insurance shall be primary insurance as respects the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers. Any insurance, self-insurance, or other coverage maintained by the City of Racine, its elected and appointed officials, officers, employees, or authorized representatives or volunteers shall not contribute to it.
- d) Any failure to comply with reporting or other provisions of the policies including breaches of warranties shall not affect coverage provided to the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers.
- e) The Contractor's insurance shall apply separately to each insured against whom claim is made or suit is brought, except with respect to the limits of the insurer's liability.
- f) Each insurance policy required by this agreement shall state, or be endorsed to state, that coverage shall not be canceled by the insurance carrier or the Contractor, except after sixty (60) days (or 10 days for non-payment of premium) prior written notice by U.S. mail has been given to the City of Racine.
- g) Such liability insurance shall indemnify the City of Racine, its elected and appointed officials, officers, employees or authorized representatives or volunteers against loss from liability imposed by law upon, or assumed under contract by, the Contractor for damages on account of such bodily injury (including death), property damage, personal injury, completed operations, and products liability.

h) The general liability policy shall cover bodily injury and property damage liability, owned and nonowned equipment, blanket contractual liability, completed operations liability with a minimum of a 24 month policy extension, explosion, collapse, underground excavation, and removal of lateral support, and shall not contain an exclusion for what is commonly referred to by the insurers as the "XCU" hazards. The automobile liability policy shall cover all owned, non-owned, and hired vehicles. All of the insurance shall be provided on policy forms and through companies satisfactory to the City of Racine, and shall have a minimum A.M. Best's rating of A-VII.

Deductibles and Self-Insured Retentions - Any deductible or self-insured retention must be declared to and approved by the City of Racine. At the option of the City of Racine, the insurer shall either reduce or eliminate such deductibles or self-insured retentions.

Evidences of Insurance - Prior to execution of the agreement, the Contractor shall file with the City of Racine a certificate of insurance (Acord Form 25-S or equivalent) signed by the insurer's representative evidencing the coverage required by this agreement. Such evidence shall include an additional insured endorsement signed by the insurer's representative. Such evidence shall also include confirmation that coverage includes or has been modified to include all required provisions 1-8.

Responsibility for Work - Until the completion and final acceptance by the City of Racine of all the work under and implied by this agreement, the work shall be under the Contractor's responsibility care and control. The Contractor shall rebuild, repair, restore and make good all injuries, damages, re-erections, and repairs occasioned or rendered necessary by causes of any nature whatsoever.

Sub-Contractors - In the event that the Contractor employs other contractors (subcontractors) as part of the work covered by this agreement, it shall be the Contractor's responsibility to require and confirm that each sub-contractor meets the minimum insurance requirements specified above.
