Dear Mr. Gitter:

On Tuesday, April 13, 2021, unit price bids were received for the 4th Street and Lake Avenue Utility Relocations project. The attached Tabulation of Bids shows the unit price bids received from all bids submitted.

Three bids were received for the project. The bids ranged from \$889,445,85 to \$999,925.00. The low bid was submitted by Super Excavators, Inc., of Menomonee Falls, WI. Super Excavators, Inc. has been prequalified with the City of Racine Department of Public Works, and they have provided the specified supporting bid documentation (Bid Bond, Affidavit of Non-Collusion, List of Proposed Subcontractors, List of Proposed Suppliers, and Project References). Therefore, we feel that Super Excavators, Inc. has the required equipment and expertise to perform the work as outlined in the contract specifications.

The engineer's estimate for the project was \$300,060.00, on the basis of open cut construction. Based on bidder feed back during and after the Pre-Bid Conference, Addendum No. 1 allowed trenchless construction methods, in order to maintain continuity of traffic to businesses and facilities along Christopher Columbus Causeway, and to maximize contractor worker safety. Maintaining public traffic flow through the 4th and Lake intersection during construction addressed concerns raised by Racine County and the Racine Fire Department, in order to maintain access to the marina and Christopher Columbus Causeway.

In addition to traffic control and trenchless construction, the following are other contributing factors based on discussions with the apparent low bidder:

- Sheeting and shoring required for open cut excavations (tunnel launch pit, and access shaft near junction structure on 84-inch interceptor)
- Densely congested existing utilities and infrastructure in the project corridor
- Depth of proposed sewer main at the west end of the alignment
- Poor subsurface soil conditions
- Volatile material supplier pricing, in particular for pipe and backfill

Therefore, we recommend award of a construction contract for this project to Super Excavators, Inc.in the low bid amount of \$889.445.85.
