CONCESSION AGREEMENT

This Agreement is made this 31 day of March, 2017 by and between the **CITY OF RACINE**, hereinafter known as "City", and **RACINE RAIDERS**, known as "Concessionaire."

For and in consideration of the mutual promises hereinafter set forth and for other good and valuable consideration, the parties hereto agree as follows:

The City agrees to permit Concessionaire and its agents and employees to operate concessions at Horlick Athletic Field in the City of Racine for a three year period and agrees to pay Concessionaire as follows:

Period 1:	March 1, 2017 through December 31, 2017	\$7,000.00
Period 2:	March 1, 2018 through December 31, 2018	\$7,500.00
Period 3:	March 1, 2019 through December 31, 2019	\$8,000.00


This Agreement shall consist of the specifications attached hereto as Exhibit A, which is incorporated herein by reference as if set out in full.
