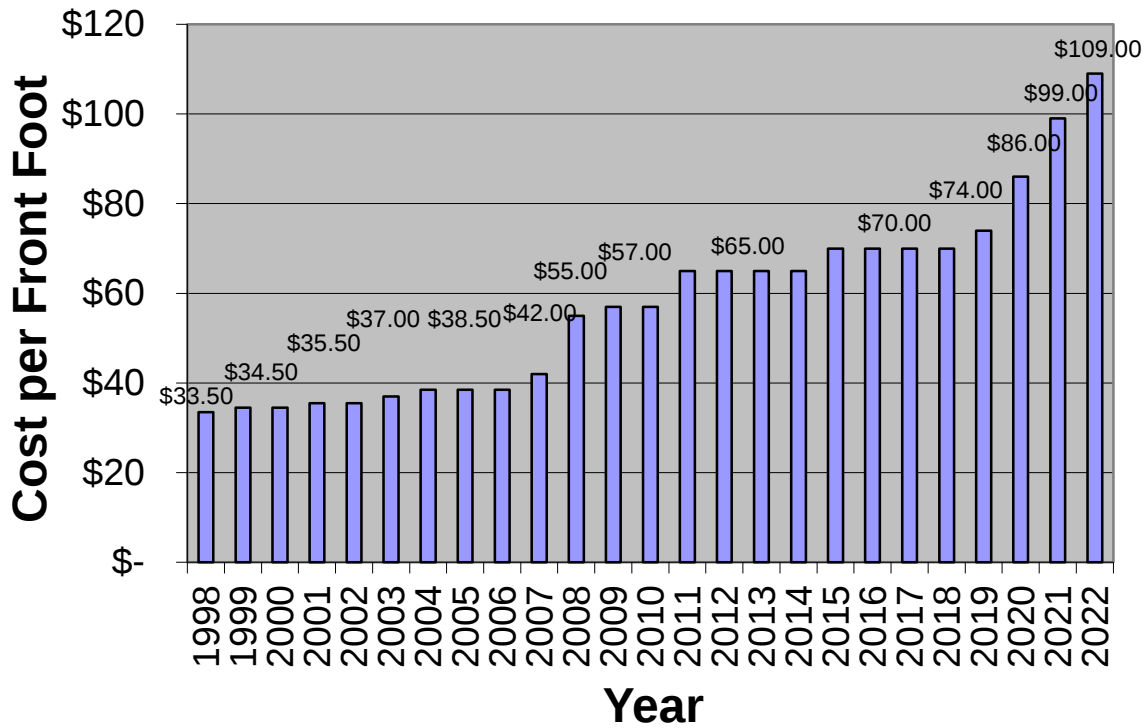
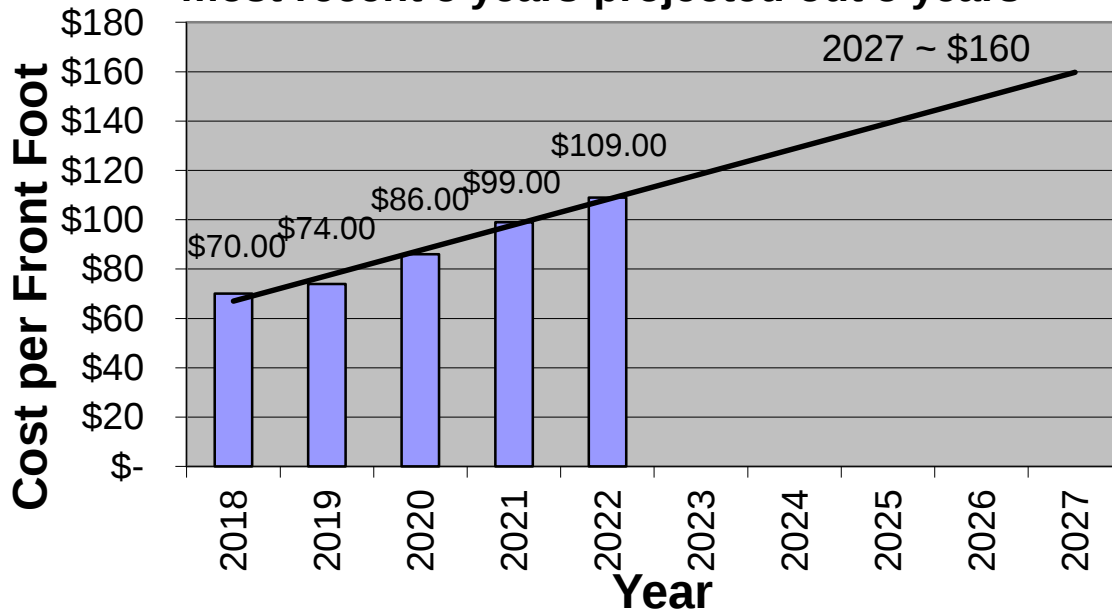


7" PCCP Residential Assessment Rates (32') 25 - year history
