Adding on to this would make our condos practically unlivable (including the decrease in our property values).

When the Chancery was in business, yes, there were times when it was loud...perhaps a drunk patron or 2 at closing. But it's nothing like the noise coming from the the Corner House now. I have heard people arguing, fighting and vomiting at times (when I used to keep my windows or balcony door open). In addition to the noise, pattrons have parked in front of our back gate, making it impossible to enter or leave our homes. I've tried to call the restaurant, with little or no success.

I currently work a job with "unusual" hours. There are numerous times when I've been kept awake by the noise from across the street. That has, unfortunately, led to problems for me at work. Opening up the patio will only increase the noise, and adding in the smells of food cooking will compound the problems.

I'm not sure why this is even being considered in a mostly residential area. Perhaps the Planning Commission, Alderman Coe, or Mayor Mason would feel differently if this was being built in their backyard.

I prefer to keep my identity private as I have had people warn me not to speak out against Mr Nelson.
