1. When I did the conditional surrender I did not know the license would come back to me if he doesn't get approved, I just know my lease stated that the license goes back to the bar if I leave the business. I have no intentions of keeping the GRC liquor license if the applicant does not get approved to be the new agent. I have not had anything to do with GRC since last year sometime. Reggie Booker has been running the bar since I left the business. I have no problem signing any papers I need to just to let you all know I will surrender them to the city if they are given back to me if the applicant cannot be approved. I left that business for personal reasons and I do not have any intentions in going back to that business. This is why I started a new business with a partner that has the same amount of knowledge that I have.
3. The problems with (GRC) and many incidents involving police. I was unaware of any issues that was going on with GRC. If I knew of the issues beforehand, I could have stepped in to correct the issues at hand. I thought that the license was already changed to him up until I was called in to the June meeting. Reggie was meeting with someone and they had him working with Amber to change the license to his name. Being this was the first time I have ever held a license I was unaware of surrendering them back to the city or back to the bar.

I pray that you take into consideration that I am starting a completely different business than GRC was. This is a business we dreamed about for many years working for my cousin Chad Londre at TBG's and we are so close in fulfilling that dream. We are looking for a sports theme bar where likeminded people who will come and enjoy the sports events happening on TV and enjoy some great food and some refreshing drinks. I am very responsible when it comes to running a bar, I just wish I was knowledgeable more on the surrendering of the license once I left. I will never make that mistake again.
