Subject:	Racine Recovery Towing			

This memo details violations of City ordinance by an "approved" licensed tow operator, Racine Recovery. I have attached documents that indicate Finishing Touch Auto Body charged vehicle owners, via insurance company representatives, substantially more for towing services than allowed by City Ordinance. Representatives for insurance companies pickup wrecked vehicles from the tow lots after accidents. The representatives have to pay the tow company a towing fee before the vehicle is released and are provided a "pay out receipt" that details the charges. Racine Recovery appears to use its' partner company, Finishing Touch Auto Body, to charge these insurance company representatives in excess of what is permitted in ordinance.

I have attached four (4) receipts from Finishing Touch Auto Body all in excess of \$1100 for tows related to crashes in the City of Racine this year and all were "next on the list" towing requests (via computer aided dispatch notes). The receipts all show a tow fee of \$385. This is far in excess of the max from the ordinance of \$135-weekend night rate. It certainly appears Racine Recovery is, at minimum, gouging insurance companies on tow bills via Finishing Touch Auto Body and likely violating City Ordinance. This places the tow companies that do comply with City ordinance at a serious disadvantage.




