**SUBJECT:** Communication sponsored by Alder Coe, per Sec. 22-1286, for the feedback report on the Commercial Electric Scooters and Licenses.

## DATA SUMMARY:

Pilot Program Data Set - June 3rd to October 11, 2021

- Total Rides = 11,021
- Average Rides Per Day = 87
- Unique Users = 2,697
- Average Trip Distance (Miles) = 2.3
- Total Distance Traveled (Miles) = 25,345.28
- Average Miles Per day = 198.01
- Average Ride Duration (Minutes) = 24.5
- Metric Tons of CO2 Saved = 5.39
- Commuters (Last 90 Days): 268 regular commuters (9% of Unique Users)
- Average number of deployed scooters: 45-50 in PROW (Available in Public Right of Way)

# Ridership

#### Total Ridership

Customers in Racine took a total of 11,021 rides over the course of a 131-day pilot period, with an average of 87 rides per day.

#### Monthly Ridership

- June = 5,233 rides
- July = 3,376 rides
- August = 1,015 rides (this is impacted by a significant dip in deployed scooters that occurred in August, which contributed to overall ridership)
- September = 1,182 rides

## Where Trips Happened

Downtown Racine and the Lakefront were popular destinations for dock less scooter travel. Local destinations of leisure were popular stops for scooter share users, especially on weekend days. As indicated by the attached map. Travel between Samuel Meyers Park to the South and the Racine Zoo to the North witnessed the most concentrated number of Bird Scooter rides.

## Injury, Crash & Incident Data

According to data provided by Bird, there were 4 self-reported incidents, one of which resulted in a medical injury due to a break issue with the scooter. After the arrival of the scooters on June 3<sup>rd</sup>, proof of identification to confirm age was required in the phone application by June 11<sup>th</sup> to prevent incidents with those under 18 utilizing the scooters.
