Approval of Minutes for the November 17, 2022 Meeting

The minutes for the November 17, 2022 meeting were approved as printed. Passed unanimously.

Racine County Sheriff's Department Water Patrol:

Nobody representing the Sheriff's Office were present to give a report.

Parks, Recreational and Cultural Service Department Report:

Tom Molbeck was not present to give updates. Secretary Molitor reported that the annual sales were \$29,783.00, half of which will go to the Park's Department and the other half to the Harbor Commission, or \$14,891.50 each. It is amazing that the sales report reflect that the sales are traditionally right around \$30,000 with the exception of the anomaly year of 2020 during the pandemic. Secretary Molitor also reported the lake water level and the downward trending elevations.

Letter of support to Racine County for improvement on North Breakwater

Racine County is asking for a support letter for their efforts on the north breakwater pier. Secretary Molitor will write the letter. Motioned and approved unanimously.

Pugh Marina: Scott Monroe of Riverside Marina was allowed to address the Commission regarding his intensions to improve the Pugh Marina riverfront. Most of the plans are only in the idea phase. Eventually he will be looking for guidance and support of the Commission regarding his plans he was directed to contact Jim Rooney to obtain contact information for the Waterways Commission. There will need to be coordination with the County and City of Racine for development and river wall changes.
