Laura Million, Business Development Manager and Ryan Brath, CEO, of Fischer USA, Inc. presented their proposal to the board.

Discussion ensued.

Brath addressed concerns about the environmental impact and offered a donation to add trees and a historical marker to the park.

Mueller expressed concern regarding the 10 year option to purchase an additional

113 ft. x 212.7 ft section of the park. Brath explained further expansion to the south may be possible in the future.

Land questioned Brath if the company would commit to stay at this site for 10 years with the expansion. Brath confirmed this committment.
