The Chief of Operations submitted the bid results on Contract C-17 in the amount of \$109,071.00. It was noted that there was only one contractor who bid on the project, that being The Wanasek Corp. Because their bid was considerably higher than the engineer's estimate of \$60,000, the consulting firm of Ruekert-Mielke, who designed the project, recommended to re-advertise the project in January 2018.
