#### NOTICE OF SPECIAL PUBLIC SAFETY AND LICENSING COMMITTEE MEETING

#### Call to Order

**1. Due Process hearing on item 191-17 of 03-14-17, being the recommendation of the Public Safety and Licensing Committee to Schedule a hearing in order to consider possible suspension and/or revocation of the "Class B" Retail Fermented Malt Beverage and Intoxicating Liquor License, for Sam's Riverbank, LLC d/b/a Days Inn Riverside located at 3700 Northwestern Avenue, Sarmad A. Naimi, Agent, which may be in violation of various sections of the City of Racine Code of Ordinances and Wisconsin State Statutes relating to alcohol licenses and as such, may be subject to suspension and/or revocation pursuant to Wis. Stat. sec. 125.12(2).**
