Subject: (Direct Referral) Communication from the Assistant Commissioner of Public Works/City Engineer, on behalf of J. Jeffers & Co., requesting a vacation of the dead end alley south of 17th Street between Phillips Avenue and Packard Avenue.

Recommendation of the Public Works and Services Committee on 11-27-18: Approves the recommendation of right-of-way vacation subject to the following conditions:

- 1. Submission of legal descriptions for vacation approved by the City Engineer's Office.
- 2. Said vacation be recorded at the Register of Deeds.
- 3. A 30' wide sewer and water easement with the north line of said easement 35' south of the south line of 17th Street between Packard Avenue and Phillips Avenue be written and recorded at the Register of Deeds.
- 4. Upon vacation of the alley right-of-way the City will maintain a 16' wide sewer & utility easement that would exist in the existing alley vacation extended south to the north line of the proposed 30' sewer and water

easement, and that this easement be written and recorded at the Register of Deeds.

- 5. The existing easements to We Energies Gas Operations (fka WEPCO Wisconsin Natural Gas) be maintained.
- 6. We Energies Electric has facilities at this location within alley right-of-way and has no system related issues with the transfer of this property. The new owner will be liable for any costs to relocate/remove these facilities for future development. The facility will remain in the easement that will be written and recorded to replace the right-of-way.
- 7. TDS Metrocom, LLC. has no facilities and no objections to the vacation.
- 8. Charter (fka TWC) has aerial facilities on WE Energies infrastructure.

Further recommends that this item be referred to the City Plan Commission.

The operator of a vehicle proceeding southerly on Douglas Avenue and approaching High Street in the lane furthest to the left shall turn left onto High Street and shall not proceed in any other direction.

The operator of a vehicle proceeding southerly on LaSalle Street and approaching Kewanee Street shall turn left onto Kewaunee Street and shall not proceed in any other direction.

Further recommends that Section 94-94, Mandatory right turns, be amended to include:

The operator of a vehicle proceeding westerly on Kewaunee Street and approaching LaSalle Street shall turn right onto LaSalle Street and shall not proceed in any other direction.

The operator of a vehicle proceeding easterly on Rapids Drive and approaching Douglas Avenue in the lane furthest to the right shall turn right onto Douglas Avenue and shall not proceed in any other direction.

The operator of a vehicle proceeding southerly on Douglas Avenue and approaching Yout Street in the lane furthest to the right shall turn right onto Yout Street and shall not proceed in any other direction.
