General Manager's Operations Report

Comparing 2018 to 2017 for February fixed route ridership was down 7%, revenue down 18%. Paratransit was up 6%, revenue up 6%.

Motion made by Balkcom, seconded by DeHahn to receive and file. Passed unanimously.

Transit and Parking System Manager's Report

Staff provided a report of revenues and expenses for the parking facilities that have revenue equipment managed by ABM, by month and facility. A large expense item for software update will be examined further.

Staff provided an update on transit planning related to Foxconn and a possible parking plan related to the Commission's request at its previous meeting recommending a discussion of parking practices to promote activity and development of the city's major commercial areas.

Commissioners expressed interest in parking practices in other cities.

Motion made by DeHahn, seconded by Balkcom to receive and file. Passed unanimously.

Motion to request the Police Department to report quarterly in-person on the number of parking citations, associated revenue, and payments to the parking utility, by month and general location.

Motion made by Kowbel, seconded by Balkcom to approve. Passed unanimously.
