Cara Pratt, Sustainability and Conservation Coordinator for the City of Racine, presented the request for permission to enter into negotiations with WE-Energies to lease a non-restored prairie area in Olsen Prairie Park for a solar array project.

Alder Carrie Glenn spoke on the item voicing concerns about what the final project will look like in the park, how it will impact the neighborhood, who will maintain it and how, cost to the city, and guarantee of stated revenue. Alder Glenn asked that the board consider these questions going forward.

Tom Molbeck spoke on the considerations and discussions that have occurred with Julie Kinzleman and Cara Pratt indicating that this is a negotiation phase and a request for final approval will be brought back to the board at a later date.
