Subject: Adoption of the Final Cost of Service Study for Lift Station No.2 Storage Tank

Recommendation: Approve

Based on Cost Of Service study (COSS) methodology consistent with the Sewer Agreement, Ruekert-Mielke derived the COSS to be applied to Lift Station No. 2 Storage Tank Project total construction costs. The COSS is applied to Sewer Service Recipient (SSR) parties of the Agreement that contribute flow to a regional project. In the case for Lift Station No. 2, the SSR parties involved are the City of Racine and Village of Mt. Pleasant. Using modeled excess flow contributions from the May 12, 2014 rain event, the COSS distribution is calculated as 86.5% for Racine and 13.5% for Mt. Pleasant.
