MWH Law Group reviewed a PowerPoint presentation on the RPD Review & Assessment study requested by the City of Racine. Presentation highlights included:

- -- No institutional race or gender bias
- -- Officers believed women or minorities were underservicing of his position
- -- Allegations that Chief did not discipline minorities or women quickly enough
- -- Shared number of specifics regarding discipline of women / minorities

-- Specific female mentioned that officers believed should not have been promoted

- over them actually had better numbers that males
- -- MWH did not believe Chief acted with bias
- -- Recommends no discipline for those who acted in good faith
- -- Better record keeping regarding policies
- -- Records, Human Resources, Generalist Dept City underscored
- -- Informal complaints have been received and processed
- -- Paid suspension guideline should be formalzed
