Mayor Mason explained to the committee the reason for the meeting, highlighting the desire to streamline the City of Racine's legislative process, increase public participation and empower the committee officials and chairs to have more say in the process and procedure. City Clerk Tara Coolidge presented the committee with a

power point explaining the six step process that is used for ordinances in the City of Racine and the Granicus/Legistar system that is used. Examples were then given of other similar sized municipalities in the State of Wisconsin and their three step ordinance process.

The Alders present and Mayor Mason had a discussion on potential procedures for items, who can submit requests and speak at public comments and hearings, how the ordinance drafting process begins, and the difference between communications, resolutions and ordinances. City Attorney Scott Letteney provided the committee with definitions of communications, resolutions, and ordinances.

The committee members moved to defer this item for two weeks until the April 3rd, 2019 Executive Committee meeting, to have more time to prepare possible solutions.
