Project Report Items A -D were suspended from being discussed per the Wastewater Commission President. Item letter E COVID 19 concerns were discussed and Commissioner Tom Bunker proposed the General Manager should be provided temporary authority to award contracts and change orders during this time of National / State emergency to ensure the Wastewater Utility can continue to serve the Community.

#### BE IT RESOLVED:

The General Manager of the Racine Water and Wastewater Utilities is granted temporary authority, while the Federal Government and State Government are under Emergency declarations as a result of the COVID -19 Pandemic, to act on behalf of the Commission to keep the Wastewater Utility operational during this time. The General Manager is hereby granted authority to award contracts, approve change orders and enter into agreements for the purchase of materials or services that may be necessary.

The following stipulations shall apply:

1) Procurement of services and other actions taken shall be within the constraints of the approved Wastewater Utility 2020 Operation and Maintenance and Capital Improvement Plan budgets

- 2) Funds must be available in order to carry out these measures
- 3) Decisions shall be made in consultation with the Mayor of the City of Racine and with the Wastewater Commission consistent with the Racine Municipal Code.

These temporary powers shall be in place until April 20, 2020 or while the state of emergency remains in existence. In addition, a representative from each sewer service recipient party would be notified of changes impacting their respective municipality.

Special note: The day after the Water and Wastewater Commissions met, the Mayor declared a declaration of emergency for the City of Racine.
