Subject: Communication sponsored by Mayor Mason presenting bid results to raze 3015-3021 Washington Ave.

Recommendation of the Public Works and Services Committee on 1-12-21: Motion made by Alder Santiago, seconded by Alder Jones, to award contract for Official Notice No. 16-2020, Raze 3015 Washington Avenue, to Veit and Company Inc., at their bid price of \$225,000, they being the second lowest responsive bidder.

Fiscal Note: Funds are available in the 2021 IG budget #45260 52340

Mr. Zens stated that the current property owner was willing to sell this property for \$1 to a viable organization that has restoration plans. He stated they have donations to assist in restoring this facility. He stated after the last Council meeting when bids were received, the building was locked up against the owner's wishes and the owner couldn't remove their items.

Ms. Michelli stated that the low bidder on the project is the person that put the lock on the door, which is criminal activity. If project is awarded, the owner should get 3 weeks back to remove items from the facility.

Ald. Santiago stated that the Landmark Status does not stop the Raze Order which was approved by Circuit Court. He wasn't in favor of demolishing the building, but it was too late to recover this building.

The Chief Building Inspector stated he has been working with the property owner for 30 months and when he was notified of a lock being placed on the facility, he personally went to remove it. Had he been notified about it from the property owner sooner, it could have been addressed at a sooner date.

Ald. Land questioned if the raze order was in effect. Kathleen Fischer responded that the raze order has been in place for over 2.5 years.
