<u>Part 1</u>: In subsection (b) of Sec. 94-17.-Traffic violation fine schedule, remove the line for Sec. 94-143 that says "Effective 1-1-2008 \$11.00."

<u>Part 2</u>: In subsection (b) of Sec. 94-17.-Traffic violation fine schedule, amend the dollar amount for 94 -145 Parking limited from "\$15.50" to "\$20.00."

Part 3: In subsection (b) of Sec. 94-17.-Traffic violation fine schedule, remove the line for Sec. 94-145

that says "Effective 1-1-2008 \$15.50."

<u>Part 4</u>: This ordinance shall take effect upon passage by a majority vote of the members-elect of the City Common Council and publication or posting as required by law.
