Title:	<ul> <li>Ragnar Relay Chicago 2018 Race</li> <li>Resolved, that permission is granted to the sponsor of the Ragnar Relay Chicago 2018 Race to use certain City streets for the period of 2:00 p.m. Friday, May 18, 2018 to 12:00 a.m. Saturday, May 19, 2018, and to use City right-of-way (sidewalks and parking lanes) along the following streets:</li> <li>Durand Ave. from West Blvd. to Sheridan Rd.;</li> <li>Sheridan Rd. from Durand Ave. to 24th St.;</li> <li>24th St. from Sheridan Rd. to Roosevelt Park Dr.;</li> <li>Roosevelt Park Dr. from 24th St. to 21st St.;</li> <li>21st St. from Roosevelt Park Dr. to Wisconsin Ave.;</li> <li>Wisconsin Ave. from 21st St. to 16th St.;</li> <li>16th St. from Wisconsin Ave. to Main St.;</li> <li>Main St. from Misconsin Ave. to Main St.;</li> <li>Main St. from Main St. to Lake Michigan Pathway;</li> <li>Lake Michigan Pathway from 11th St. to Main St.;</li> <li>Moichigan Blvd. from Dodge St. to Reichert Ct.;</li> <li>Reichert Ct. from Michigan Blvd. to Lake Michigan Pathway;</li> <li>Lake Michigan Pathway from Reichert Ct.;</li> <li>Meiving Anete Michigan Pathway to Main St.;</li> <li>Main St. from Main St. to Erie St.;</li> <li>Erie St. from Main St. to Erie St.;</li> <li>Erie St. from Main St. to Erie St.;</li> <li>Erie St. from Shoreland Dr.;</li> <li>Shoreland Dr., from Alie Rd.; and</li> <li>3 Mile Rd. from Erie St. to Charles St. (Vidian/Cheska Park).</li> <li>Further resolved, that this permission is granted with the following stipulations:</li> <li>A. A hold harmless agreement be executed and a \$75.00 processing fee paid.</li> <li>B. A liability insurance certificate be filed prior to this event.</li> <li>C. Any overtime costs incurred by any City department be charged to the sponsor.</li> <li>D. The sponsor shall notify all abutting property owners 72 hours in advance of this event.</li> </ul>						
	E. The sponsor shall pay a \$250.00 special event fee.						
	F. If required, sponsor shall be responsible for submitting a Temporary Traffic Control Plan to the Engineering Department for approval, and providing and removing all temporary traffic control device and detour signs.						
	G. If required, sponsor shall provide a detour plan for the closure of all State Connecting Highways, arterial and collector streets to the City Engineer for approval.						

H. If required, sponsor is responsible for cleaning the streets.

	<ul> <li>I. If required, sponsor shall install parking meter hoods or temporary parking signs at least 24 hours in advance of the event, and if this is not done, sponsor is responsible for vehicle towing and parking violation expenses of the violators.</li> <li>Further resolved that the Commissioner of Public Works, City Engineer and Chief of Police, shall provide limited assistance in the interest of public safety to implement this event in accordance with these stipulations.</li> </ul>					
	Fiscal Note: There will be nominal costs to the various City departments, on a regular shift basis, to assist in implementing this event.
