June 10 & 22, 2026	Department of Agriculture, Trade and Consumer Protection (DATCP)	Agent evaluation process changes	DATCP has formally defined the process, criteria, corrective measures & outcomes for the on-site agent evaluation audit that occurs every 3 years. Improvements include an evaluation form to improve consistency between DATCP auditors, standardized corrective action plans & a score form grading the environmental health program for comparison between other jurisdictions.
June 17, 2026	Department of Health Services (DHS)	Childhood lead poisoning prevention program (CLPPP)	Sanitarian attended a Q&A overview of the Ages & Stages Questionnaire (ASQ), a tool used in evaluating childhood development for the CLPPP.
June 26, 2026	Internal Standardization Exercises	Initial standardization	Sanitarian passed her initial 8 standardization exercises that include inspecting an establishment that serves a highly susceptible population, an establishment that has a Hazard Analysis of Critical Control Points (HACCP) plan and a grocery store with deli. Additionally, the candidate needs to create process 1, process 2 & process 3 food flows, a risk control plan, and HACCP verification worksheet.
