#### **Friday, May 29, 2026**

**Select 627** - 1111 Washington Ave - Officers were dispatched in reference to a fight. Parties were identified and then released. Officers attempted to conduct a license premise check and the lights were shut off and door was closed. Officers then knocked and eventually made contact with a bartender. It should be noted 12 patrons were still inside as officers made entry. Bartender did not have a valid operators license and was issued a citation. The bartender was the only one on scene and advised the owner left an hour prior to police arriving. Owner was also issued a citation. **26-026758**
