Please be informed that the Public Safety and Licensing Committee of the Common Council of the City of Racine will meet at 5:00 P.M., on Wednesday, July 15, 2026, in room 303, City Hall to discuss the issuance of a formal expression of concern under section 6-27 of the City of Racine Code of Ordinances, as it relates to the above premises including but not limited to the following issues:

06/13/2026 Taste of Soul Bar and Grill - 501 Sixth St - Officers were dispatched in reference to several people hanging outside the bar. Officers dispersed the crowd and a license premise report was completed. No violations observed at this time. 26-029765

06/16/2026 Tast of Soul Bar and Grill – 501 Sixth St. - Officers were dispatched in reference to a noise complaint. The complaint was unfounded. 26-030574

06/20/2026 Taste of Soul Bar and Grill – 501 Sixth St – Officers were dispatched in reference to a large crowd outside the tavern. Officers arrived and observed approximately 40-50 standing outside the tavern. Officers assisted in dispersing the crowd. Some became argumentative and were eventually detained in handcuffs. A license premise report was completed and no violations documented. 26-031240

06/28/2026 Taste of Soul Bar and Grill – 501 Sixth St - Officers were dispatched in reference to a fight. Upon officers arrival, they did not observe a fight. A license premise report was completed with no violations observed. 26-032761

Sec. 6-27. - Actions by the committee.

(a) Formal expression of concern. (1) The public safety and licensing committee may require the appearance of any licensee before the committee at any time to address issues related to the licensed premises through a written formal expression of concern, sent via first class mail to the licensee. (2) If the licensee fails to appear for the formal expression of concern, the committee may refer the matter to the city attorney's office for consideration of further disciplinary action. (3) If the licensee appears for the formal expression of concern, no discussion of the alleged facts may be permitted unless the licensee requests such discussion and only after the licensee has been advised that any statements made by him or her and/or his or her representatives regarding the alleged underlying facts may be considered by the due process board in any subsequent suspension/revocation hearing which may result from the alleged violations which are the subject of the formal expression of concern. (b) Referral for disciplinary proceedings. (1) Any licensee who has been issued two formal expressions of concern within a six month period, or three or more formal expressions of concern within a one year period, shall be referred to the city attorney's office for consideration of further disciplinary proceedings as contemplated under section 6-26 of this Code. For purposes of this section, the date the committee votes to issue a formal expression of concern shall be the date used to calculate any time period prescribed. (2) Nothing in this section shall be construed to conflict with, abridge or modify, the rights or procedures established for revocation or suspension of licenses in Wis. Stats. § 125.12 provided there is cause for disciplinary proceedings under the relevant ordinances or statutes.
