Thursday, March 12, 2026

Olive Garden - 6000 Durand Ave - Officers were dispatched in reference to an unwanted party. Contact was made with party who was advised **26-011950**
to leave. A license premise report will be completed.

Castle Lanes - 5615 Castle Ct - Officers were dispatched in reference to an accident. It was learned the accident was caused due to reckless **26-011992**
