DEED ✓

CLARENDON I. SHOOP

TO

CITY OF RACINE

WHEREAS, Clarendon I. Shoop, the undersigned, grantor, has long been a resident of the City of Racine, and interested in its growth and welfare, and is desirous of conveying to said City the tract of land hereinafter described in order that the same may be held and used by said City of Racine for Park purposes, the grantors reserving to themselves only the right to build or erect on a part thereof a home or homes for aged men.

NOW THEREFORE, THIS INDENTURE, made this 2nd day of April, A.D. 1917, between Clarendon I. Shoop, and Ida M. Shoop, his wife, of the City and County of Racine, State of Wisconsin,

parties of the first part, and City of Racine, a municipal corporation, party of the second part,

WITNESSETH:

That the said parties of the first part in consideration of the foregoing, and of the sum of One (\$1) Dollar to them in hand paid by the party of the second part, receipt whereof is hereby acknowledged, and further considerations, among which are that the property hereinafter described shall perpetually bear the name of "SHOOP PARK", and that part of the premises located on the West side of the highway which divides the said premises, devoted to a home or homes for aged men, - the name of "SHOOP HOME FOR AGED MEN", do by these presents grant, bargain, sell, release, convey and quit claim to the said party of the second part, its successors, forever, that certain parcel of land lying and being in the County of Racine, State of Wisconsin, described as follows, to-wit:

"That part of the Northeast fractional quarter (N.E.  $\frac{1}{4}$ ) of Section twenty-seven (27) in Township four (4) North, Range twenty-three (23) East, bounded: Begin one and four hundred ninety-five thousandths (1.495) chains East from the South west corner of said Northeast quarter; thence North twenty and nine hundredths (20.09) chains to the South line of land heretofore conveyed to one Jandl; thence East along same to Lake Michigan; thence Southerly along the Lake to the South line of said Northeast quarter (NE  $\frac{1}{4}$ ); thence West to the beginning; also

Part of the Southwest fractional quarter (SW  $\frac{1}{4}$ ) of said Section twenty-seven (27) Township four (4) North, Range twenty-three (23) East, bounded: Begin at the Northeast corner of said quarter section; thence West six (6) chains eighty (80) links; thence Southeasterly to Lake Michigan to a point five chains from beginning; thence Northeasterly along the Lake Shore to beginning.

Also all rights of the grantor to operate a railroad track across the premises conveyed to Frank Jandl by deed recorded in Vol. 115 of Deeds, page 421."

Said Clarendon I. Shoop, one of the said parties of the first part, reserving to himself, and his heirs and legal representatives, the right to build a home or such number of homes for aged men on that part of the premises located on the West side of the highway which divides the said premises, as he may see fit to erect; - he expressly promising and agreeing that all such homes so erected shall be supported and maintained by him in his lifetime and thereafter by the income of a fund which he agrees to create and set aside for the purpose of such maintenance, the conditions of occupancy of such home or homes as he may erect or provide to be erected, to be prescribed and fixed by the said grantor; the homes so erected to be so planned and constructed that the same shall not detract from the appearance of the landscape and surroundings and so to be maintained by the said grantor and after his death by the income of the fund hereinbefore agreed to be provided by him.

In further consideration of the said grant, it is understood between the parties hereto that the hereinbefore described property shall forever be held, maintained and improved by the City of Racine for Public Park purposes, except such part thereof as may be necessary to the proper enjoyment and use of the homes for Aged Men.

TO HAVE AND TO HOLD the same together with all and singular the hereditaments and appurtenances thereunto belonging or in any wise appertaining unto the said party of the second part, and its successors, forever.

And the said parties of the first part, for themselves, their heirs, executors and administrators, do covenant with the said party of the second part, and its successors that they have not made, done, executed or suffered to be done any act or thing whatsoever whereby the above described premises, or any part thereof, now or at any time hereafter shall,

or may be imperiled, changed or encumbered in any manner whatsoever.
