

Uptown Pub and Grill 1510 Junction Av.

Calls for Service : (4/28/2025/04/28/2026) Calls for Service 15

4/12/2026

Uptown Pub and Grill - 1510 Junction Ave - Officers were dispatched in reference to a fight call. Officers learned two individuals with masks made entry into the business and confronted a male. Parties left prior to police arrival. A license premise report was completed.

4/12/2026

Uptown Pub and Grill - 1510 Junction Ave - Officers were dispatched in reference to a fight call. Officers did not observe an active fight and a license premise report was completed.

4/06/2026

Uptown Pub and Grill - 1510 Junction Ave - Officers were dispatched in reference to shots fired. Officers located a scene consisting of spent casing in the 1500B of Junction Ave. As officers arrived on scene, multiple people were leaving the area and some with firearms. A party was struck by gun fire. Investigation is on going in reference to the incident.

Officers conducted a license premise check and bartended was unable to provide an operators license.

4/05/2026

Uptown Pub and Grill - 1510 Junction Ave - Officers were dispatched in reference to a noise complaint. Officers arrived on scene and observed multiple vehicles on both the east and west side of the road. Officers advised they observed approximately 100 patrons inside the bar and they were unable to see the occupancy limit posted. They completed a license premise report with no other violations observed. Officers advised it took approximately 33 minutes to clear the crowd and vehicles from the area. A total of ten RAPD squads were on scene with an additional RSCO squad to assist and disperse the crowd.

3/28/2026

Uptown Pub and Grill - 1510 Junction Ave - Officers responded to the bar for a report of a fight. Prior to officers arriving on scene, the problem parties left. A license premise check was completed during which it was found that the bartender on duty did not

possess nor could verify if they had a bartending license. A citation was issued for the related offense.

Uptown Pub and Grill - 1510 Junction Ave - Officers were dispatched in reference to an unwanted party. Party left prior to police arrival. A license premise report was completed and no violations were observed.
