

Sec. 66-3. - Payment of forfeiture in lieu of court appearance.

(a) Any person charged with a violation of the offenses listed under subsection (b) of this section may pay the amount enumerated therein at the office of the municipal court in lieu of a court appearance. Persons wishing to contest charges contained in subsection (b) of this section may contact the office of the municipal court to arrange a court appearance date.

(b) The following forfeitures for the offenses listed herein may be paid at the office of the municipal court:
