Calls for Service(4/28/2025-04/28/2026) : 12

4/25/2026

Honors - 1330 Washington Ave - Officers were dispatched in reference to a noise complaint. Officers on scene made contact with the bartender who did not have the operators license with them.

04/15/2026

Honors Racine - 1330 Washington Ave - Officers were dispatched in reference to a fight. Arrest were made in reference to the incident. It was also learned, one of the parties involved was 18 years of age and was drinking inside Honors. A citation was also issued for underage consumption of alcohol.

4/09/2026

Honors Racine - 1330 Washington Ave - Officers conducted follow up in reference to an assault that took place after parties left the bar. During the investigation it was learned a juvenile was drinking at Honors and the juvenile was only 17 years old. Juvenile advised that they had been to the mentioned bar prior to this day. After speaking to the bartender, they advised they were unaware that the party was a juvenile due to them having the ID check prior and being at least twenty one. Bartender advised party was recognized from previous times and was not ID prior to re entry into the bar.

4/07/2026

Honors Racine - 1330 Washington Ave - Officers were dispatched in reference to a fight in progress. Officers reported numerous parties were involved in a mutual fight that occurred inside of Honors and carried into the street. Multiple parties were arrested in reference to this incident. It should be noted, one of the parties involved in the fight was the bartender that was working for Honors on this night. License premise report was completed.

3/26/2026

Honors Racine - 1330 Washington Ave - Officers responded after a concerned citizen requested a welfare check on the bartender. The bar was already closed when officers arrived on scene. No license premise check completed.

3/05/2026

Honors Racine - 1330 Washington Ave - Officers were dispatched in reference to a fight. Upon officers arrival, the problematic parties left the area. A license premise report was completed and no violations observed.

1/25/2026

Honors Racine - 1330 Washington Ave - Officers were dispatched in reference to an unwanted party. Party came inside the bar and was being disorderly. Officers made contact with the male and he was advised he was trespassed from the bar. License premise report was completed.

1/21/2026

Honors Racine - 1330 Washington Ave - Officers were dispatched in reference to a fight. It was learned a male assaulted a female inside the bar and the incident was captured on video. Staff was cooperative and provided police with video surveillance of the incident. A license premise report was completed.

Bartender advised as they were closing the bar, two parties began to argue, and a fight ensued. Parties left after bartended advised they were calling the police.
